| Description | It is emphasized that provision of gifts/incentives in any form to shareholders at or in connection to General meetings is strictly prohibited under Section 185 of the Companies Act, 2017. It is therefore reiterated that granting gifts to shareholders is an offense and companies in default or not complying with the requirement of law shall be liable to be penalized under Sub-section (2) of section 185 of the Act. |
