**PROTOCOL PASSES FOR LEADING EXPORTERS FOR
ACCESS TO LOUNGES OF NATIONAL AIRPORTS DURING 2010**

The Government of Pakistan has decided to issue Protocol Passes for the year 2010 to the leading exporters having Export Performance of **US\$ 10 million** or more during the fiscal year 2008-2009.

Exporters who fulfill the above criteria may send their applications to the Trade Development Authority of Pakistan, Karachi latest by **13th January, 2010** through their respective Trade Associations/Chambers alongwith duly completed application forms in all respects as well as verified proof of their export performance by the concerned bank and products exported.

As regards the Security verification by concerned Government agencies, the procedure will remain the same as that of the previous year and the applicants will follow the process themselves. The Application and the Security Clearance Forms may please be obtained from the Head Office and Regional/Sub-Regional Offices of Trade Development Authority of Pakistan.  - i) Intelligence Bureau : Security vetting Proforma are required in triplicate.
 - ii) Special Branch Police : Special Branch Police clearance will be obtained by the applicant himself and enclosed with the application.
 - d) Security Clearance: For other than Government Servants Certification to the effect that the applicant(s) is / are security cleared by IB / Spl. Branch Police and in case of involvement of the individual(s) in subversive activities/misconduct. The Head of Deptt. / Nominated Officer will be held responsible.
 - e) Copy of NIC & Departmental Identity Cards duly arrested.
 - f) Undertaking/Justification Proforma (Elaborately the need of Empty).
 - g) Copy of Posting/Appointment letter / Gezette Notification.
3. Airport Entry Passes are issued on 'Need to Enter' basis for the purpose for which issued only. Misuse may result in cancellation.
4. In case of facial change at any stage, the holder himself will be responsible to obtain revised pass otherwise access into restricted area will be denied.
