Procedure For Application

Exporters who wish to avail this assistance are requested to observe following procedure.

- Applicant firm selects an accredited certification agency for the relevant certification program, finalizes terms and conditions with it and submits application to TDAP.
- Evaluation and acceptance of the request by TDAP.
- Completion of certification requirements by the applicant firm leading to award of certificate by the certification agency.
- Submission of the certificate alongwith Agreement signed with certification body and payment receipts to the Director (Facilitation) for release of payment.
- For certifications where surveillance Audit is required, 50% payment will be released upon attainment of certificate and balance 50% will be paid upon production of satisfactory surveillance Audit Report.
