

Procedures for Export of Wheat Products (Atta, Suji & Maida)

Export of Wheat products (Atta, Suji & Maida) is allowed subject to the following conditions:-

1. General Procedures & Conditions:-

- a. Export shall be limited to a cumulative ceiling of 200,000 MT of Wheat products (Atta, Suji & Maida).
- b. Individual exporter shall be allowed to export a minimum quantity of 50 MT and maximum of 500 MT per contract.
- c. Basis of exports shall be as per Para- 3 of the Export Policy Order (EPO) 2008.
- d. Exports shall be allowed only in dollar terms.
- e. The export shall be made after prior registration of export contract with Trade Development Authority of Pakistan (TDAP).

2. Export Contract Registration:-

- a. Applications for registration of export contract duly verified by the banks of exporter shall be received in the offices of Trade Development Authority of Pakistan at Islamabad, Karachi, Lahore, Peshawar and Quetta on the specified form as per Annex –I
- b. Following documents shall be attached with the application of contract registration: -
 - i. Bank verified copy of export contract.
 - ii. Copy of National Tax Number certificate & of Sales Tax Registration Certificate
 - iii. Security Deposit in form of Pay Order / Demand Draft equivalent to Rs.5, 000/50MT (Five Thousand Only) in favor of Accounts Officer EMDF, TDAP Karachi.
- c. TDAP after confirming availability of the ceilings shall register the contract and forward copies of export contract on the next working day to JS (Exports), Ministry of Commerce, JS (Food), Ministry of Food & Agriculture and Collector of Customs of the indicated export station.

3. The contract shall be valid for export within sixty (60) days of issuance failing which the amount of security deposit shall be forfeited.
