**ABOUT RECOGNITION OF SARGODHA , PUNJAB PROVINCE AS CITRUS PRODUCTION CENTER AREA  
PEST FREE KINNOW MEDITERRANEAN FRUIT FLY ( Ceratitiscapitata ) IN PAKISTAN**

BY THE GRACE OF GOD ALMIGHTY

The Minister of Agriculture ,

Considering :

a. that ' the Minister of Agriculture Regulation No.42/Permentan / OT . 140/6/2012 set Quarantine Measures for Importation of Fresh Fruits Fresh Fruits And Vegetables Into the Territory of the Republic of Indonesia ;

b .that under Article 4 of Regulation of the Minister of Agriculture No. 42/Permentan/OT .140/6/2012 determination of the production area in the country of origin is free from fruit fly infestation , set by the Head of Agricultural Quarantine Agency on behalf of the Minister in the form of decision ;

c . that based on the results of the assessment and verification of Sargodha , Punjab province as kinnow citrus production center area , has met the requirements to be recognized as a pest -free area of the Mediterranean fruit fly ( Ceratitiscapitata ) ;

b . Based on the considerations referred to in paragraphs a, b , and c , need to give recognition to Sargodha , Punjab province as a center for citrus production area pest-free kinnow the Mediterranean fruit fly ( Ceratitiscapitata ) ;

FIRST : Against Recognition Sargodha , Punjab province as a center for citrus production area pest-free kinnow the Mediterranean fruit fly ( Ceratitiscapitata ) in Pakistan .

THIRD FOURTH

Pakistan's Plant Protection Department shall provide a report to the Agriculture Quarantine Agency when in the area as referred to in the FIRST statement or the outbreak of pests detected fruit fly ( Ceratitiscapitata).

Recognition referred to in the FIRST statement revoked , if based on the results of the verification indicate that the Department of Plant Protection of Pakistan can not sustain Sargodha , Punjab province as an area free of fruit hamalalat Mediterranean ( Ceratitiscapitata ) . This Decision shall apply from the date specified .
