ABSTRACT

This paper analyzes the US GSP Program and its free tariff lines accorded to Pakistan & it also highlights sectorial utilization of these tariff lines by Pakistan.

Introduction

The US is an attractive market for all developing and least developing economies throughout the world and especially those that are accorded GSP free preferential treatment, However, for Pakistan particularly there is a significant untapped potential that can be utilized to expand its export base and overall bilateral trade volume, this study is based on the GSP free tariff lines that are accorded to Pakistan and their utilization ratio in different sectors.

In this regards the free tariff lines accorded to Beneficiary Developed Countries are analyzed on sectorial level and three categories are drawn based on the exports of Pakistan to US. Namely they are category "A" tariff lines with considerable exports, category "B" tariff lines with negligible exports and category "C" tariff lines with zero exports to US.

Further, this study provides an overview of the US GSP Program with its prerequisite eligibility criteria and graduation mechanism, along with the list of countries and association that enjoy these preferential treatments. Moreover, in order to analyze the list of free tariff lines for Pakistan data has been extracted from different US official data basis on Harmonized system (HTSUS) at 08 and 06 digits. Two-pronged strategy is adopted on two streams of data and potential sectors are highlighted for exports to the US under GSP free tariff lines.

U.S. Generalized System of Preferences (GSP)

The U.S. Generalized System of Preferences (GSP), is a program designed to promote economic growth in the developing world, provides preferential duty-free treatment for over 3,500 products from a wide range of designated beneficiary developing countries (BDCs), including many least-developed beneficiary developing countries (LDBDCs). An additional 1,500 products are GSP-eligible only when imported from LDBDCs. The GSP program, first authorized by the Trade Act of 1974, came into effect on January 1, 1976. Authorization of the GSP program expired on December 31, 2017. On March 23, 2018, the President signed legislation authorizing the GSP program through December 31, 2020, retroactive to January 1, 2018.

1. Eligibility Criterion for GSP Preferential Treatment

To be eligible for duty-free treatment pursuant to GSP, an import must meet the following requirements:

1.1 GSP-Eligible Articles

- (1) It must be included in the **list of GSP-eligible** articles.
- (2) It must be **imported directly** from a BDC.
- (3) The **BDC must be eligible** for GSP treatment for that article.
- (4) The article must be the growth, product, or manufacture of a BDC and **must meet the value-added** requirements.
- (5) The importer **must request duty-free treatment under GSP** by placing the appropriate GSP Special Program Indicator (SPI) (A, A+, or A*) before the HTSUS number that identified the imported article on the appropriate shipping documents.

1.1.1 If GSP treatment is not claimed on entry

If GSP treatment is not claimed on the entry summary, there are other ways to claim it. One is to file a Post Summary Correction (PSC) with US Customs and Border Protection (CBP) at **least 20 working days** prior to liquidation of the entry. Another method is **to file a protest** against the decision of custom service as set out in section 1514 Tariff Act 1930 for recovery of duties.

1.1.2 Documents required to ensure GSP duty-free treatment

The documents that CBP may request vary on a case-by-case basis. Examples of the types of documents that should be available to establish and document a GSP claim are:

- GSP declaration (Evidence of country of origin)
- Bill of materials
- Invoices
- Purchase orders
- **Production records** kept in the ordinary course of business
- Payroll information to document labor costs
- Factory profile
- Affidavit with supporting documentation

The documentation necessary to substantiate a GSP claim must be kept readily accessible, should CBP request it. CBP may request records from the importer, from the foreign exporter, or both. The substantiating documentation must be kept for a period of five years.

2. Graduation of a Beneficiary Country from GSP

Graduation is the removal of a country's GSP eligibility on the basis of factors related to **national income or competitiveness**. The US President may remove a BDC from the GSP program because the country is sufficiently developed or competitive or **may suspend or limit the BDC's access to duty-free treatment with respect to one or more products.** Country graduation occurs.

- 1. When the President determines that a beneficiary country is a "high-income country," as defined by the GSP statute (based on World Bank statistics) ("mandatory graduation"); or
- 2. As the result of a review of a BDC's advances in economic development and trade competitiveness. The per capita Gross National Income (GNI) limit for mandatory graduation is set at the lower-bound of the World Bank's definition of a "high-income" country (which was \$12,376 for 2018, the most recent data available, announced in July 2019). Mandatory graduation takes effect January 1 of the second year after the year in which the President makes the graduation determination, which is announced in the Federal Register.

2.1 Factors are considered in graduation actions

For circumstances other than mandatory graduation, the GSP Subcommittee normally reviews:

- (1) The country's **general level of development**.
- (2) Its **competitiveness** in regard to the **particular product**.
- (3) The country's **practices relating** to trade, investment, and **worker rights**.
- (4) The **overall economic interests of the United States**, including the effect continued GSP treatment would have on the relevant U.S. **producers**, **workers and consumers**; and
- (5) any other relevant information.

3. Rules-of-Origin Requirements

For an imported article to be GSP-eligible, it must be the growth, product, or manufacture of a BDC, and the sum of the cost or value of materials produced in the BDC plus the direct costs of processing must equal at least 35 percent of the appraised value of the article at the time of entry

into the United States. CBP is charged with determining whether an article meets the GSP rules of origin.

An importer, exporter or producer who is uncertain about whether a particular imported article satisfies the rules of origin requirements, may check CROSS, CBP's searchable database, http://rulings.cbp.gov/, to see if CBP has issued a ruling on the same or a similar product, or may contact CBP for a binding ruling.

3.1 Can imported materials be counted toward the 35 percent value-added requirement?

Yes, if the imported material undergoes a **double substantial transformation**. This means that the imported material **must undergo a substantial transformation in the BDC**, whereby **imported material is transformed** into a new and different constituent material with a **new name**, **character**, and use.

Inputs from member countries of GSP-eligible regional associations will be treated as single country inputs for purposes of determining origin.

3.1.1 Imported Directly" Requirement

Generally, the imported article must either be shipped directly from the BDC to the United States without passing through the territory of any other country. If a shipment from a BDC passes through the territory of any other country on the way to the United States, the imported articles must not enter the commerce of the other country.

3.1.2 Does the GSP program make any special provisions for BDCs that are members of a regional association?

Yes. If members of regional associations request and are granted recognition as regional associations under the GSP program, the association's member countries will be **considered as one country for purposes of the GSP rules of origin**. Articles produced in two or more eligible member countries of an association will be accorded duty-free treatment if the countries **collectively meet the rules of origin**. In addition, an article produced in an LDBDC may count inputs from LDBDCs and BDCs in its regional association towards the 35 percent domestic content requirement for satisfying the rules of origin for qualifying articles.

3.1.3 Do all beneficiary countries receive duty-free treatment on the entire list of articles?

No. Some otherwise GSP-eligible products from BDCs may be ineligible because:

- (1) They exceed the **Competitive Need limitations** (**CNLs**) **requirement** which are quantitative ceilings on GSP benefits for each product and BDC. The GSP statute provides that a BDC is to lose its GSP eligibility with respect to a product if the CNLs are exceeded and if no waiver is granted. There are two different measures for CNLs: when U.S. imports a product from a BDC during any calendar year
- Account for **50 percent** or more of the value of total U.S. imports of that product; or
- Exceed a certain dollar value; the limit was \$175 million in 2016 and was **\$180 million in 2017**. (In accordance with the GSP statute, the dollar-value limit is increased by \$5 million annually)
- (2) The products' GSP eligibility has been removed from one or more particular countries in response to **petitions submitted** as part of an annual review.
- (3) a particular BDC has been found **to be sufficiently competitive** with respect to that product or products
- (4) The imported articles fail to meet the statutory requirements of GSP; or
- (5) The imported articles fail to meet other CBP or other agency requirements.

5. PAK-US GSP Trade Analysis

The US is one of the major trading partner of Pakistan and bilateral trade between both the countries reached at US \$6.65 billion in the year 2019, whereas the balance of trade remained tilted in favor of Pakistan as it exported US \$4.04 billion worth of goods to the US market. On the contrary, Pakistan imported US \$2.61 billion worth of goods resulting in trade surplus of US \$1.42 billion, which records a 64 per cent increase in year on year basis due to the significant decline in imports from US. However, the trade volume is recording an increasing trend over the last five year with a meager decrease in the year 2016.

6. Methodology of the study

Two-pronged strategy has been employed to analysis GSP free tariff lines, one is to identify free tariff lines at HS 02 chapter for sectors analysis and the other is to analysis actual export figure under GSP free tariff lines based on the sectorial categorization drawn in first strategy.

Thereby, in the first stage data on tariff lines published on the US Trade Representative website was analyzed, which was in the form of Harmonized system (HS) 08 digits level. However, the sectorial analysis demanded the data to be at chapter level, thereby tariff lines are delimited to HS 02 in the first stage for categorization, and later expanded to HS 08 in order to highlight potential products that can be readily utilized.

Therefore, at the first stage the list of 3500 GSP eligible products/tariff lines for all beneficiary countries identified for beneficiary developing countries (BDCs) were analyzed and in order to avoid ambiguity products with Special Program indicator (SPI) A* were excluded due to limitation of data on those products.

In the Second stage the data from the US Census Bureau received from our Trade Minister in Washington was analyzed based on the afore drawn categorization in order to highlight Pakistan's export to US in the year 2019 under GSP free tariff lines. and, also to ascertain the discrepancy in first stage of analysis due to data limitation and further to highlight sectors that are utilizing free tariff lines and those that remains underutilized.

The above give table 03 shows the distinction of tariff lines based on sectorial analysis. Thereby the accumulated tariff lines in which Pakistan has significant exports to US are identified as tariff lines with considerable exports (See table 04 for details), whereas similarly tariff lines in which Pakistan has negligible exports to US in the year 2019 are also highlighted in table 05 and lastly tariff lines which remains underutilized wherein Pakistan has zero exports to US is also being incorporated (See table 06 for details).

However, the limitation of conducting study as Hs 02 is that when exports figure at sectors level are analyzed sectors which has less number of GSP free tariff lines will mislead the result and in our case chapter 62 and 63 in table 05 reflect that, because it doesn't signify the actual exports figures under GSP free tariff lines but rather export to the US Market in those sector drawn at sectorial level, as most of the textile related products are ineligible for GSP treatment in Pak-US GSP.

6.1 Analysis of Exports to US under GSP eligible free tariff lines at Hs 06 Code

In this stage the study analyzes the list of tariff lines on which Pakistan has exported to the US in the year 2019 on the data of US Census Bureau shared by Pakistan's TIO in the US, which are then compared on sectorial level for its utilization ratio and also highlight those sectors that are comparatively better utilizing GSP free tariff lines for its exports in their respective sectors.

The table 08 below gives a list of utilized GSP free tariff lines as against the actual GSP eligible tariff lines in each sector in order to analyze each sector utilization ratio. Which highlights that out of 98 chapters 37 chapters are altogether not utilized for any GSP free trade. Which includes chapter 29 with highest tariff free lines of 407 and the 4th highest tariff free lines 168 of chapter 28 for organic and inorganize chemicals, respectively.

The table 08 table also shows that chapter 57 Carpets and other textile floor coverings and 61 Articles of apparel and clothing accessories, knitted or crocheted have recorded a 100 percent free tariff utilization ratio in the calender year 2019 followed by chapter 09 Coffee, tea, maté and spices and 61 Articles of apparel and clothing accessories, not knitted or crocheted with 60 and 50 per cent respectively.

In total 73 GSP eligible textile items of Pakistan are exported to US amounting \$ 32.06 million against the total US GSP Textile imports of \$ 189.254M in the calender year 2019 which equates to 16.9 percent.

7. Conclusion

This study analyzes the GSP free tariff lines accorded to Beneficiary Developed Countries sectorial level based on categories drawn on the exports of Pakistan to US. Namely these categories are Category "A" which includes tariff lines with considerable exports, category "B" that includes tariff lines with negligible exports and category "C" that contain tariff lines with zero exports to US.

Each category identifies sector in which there is export potential for Pakistan, such as in category "A" which covers 788 free tariff lines and 18 chapters at HS 02 digits with significant exports, therein it identifies Chapter 84 with most of the free tariff lines (see table 14 in Appendix for details). And this chapter is one of the most crucial sectors with third highest worlds imports, such preferential treatment in world's biggest economy is unmatchable opportunity for Pakistan to set its target in a medium and long term to establish strong supply base for this sector and to harness maximum benefits from these free tariff lines.

Moreover, this category also highlights that the major exports to US are of the sectors in which Pakistan has least free GSP tariff lines.

Further, in category B, sectors with negligible exports are analyzed that covers 48 chapters and 1516 free tariff lines. It is pertinent to highlight that this category has most of the free tariff lines, and this study identifies 07 chapter in which Pakistan has considerable free tariff lines and well establish supply base but negligible exports to US (see table 15 in Appendix for details of tariff lines), and most important of these sectors are chapter 07, 74, 08 and 03 (see table 16 in appendix for details) with meager exports to US.

Similarly, in category C, sectors with zero exports are highlighted, which cover 25 chapters and 942 free tariff lines. Among these sectors Pakistan has significant exports and establish supply base in 04 chapter (see table 17 in Appendix for details of tariff lines), but there are zero exports to the US market. Therefore, this study stresses upon utilization of these tariff lines for the maximum benefits in exports to US market.

Additionally, this category also highlights that the major free tariff lines are for inorganic and organic chemicals. Wherein Pakistan has meager exports to the world for organic chemical chapter 29, However, it has a considerable supply base for inorganic chemical at chapter 28, it is pertinent to

highlight that inorganic chemical is the sector with forth most free tariff lines accorded (see table 18 in appendix for details), but unfortunately there is zero utilization ratio, therefor, in a medium and long run these two sector may also be targeted to utilize most from the free tariff lines accorded to Pakistan in GSP preferential treatment.

Lastly, the data of US Census bureau on the imports of US under GSP tariff lines are analyzed, which highlights that Pakistan has only utilized 305 tariff lines which accounts for 8.68 per cent of total free tariff lines in the year 2019, whose exports value equates to US \$344.65 million and only 1.71 per cent of US total imports under GSP free tariff lines, which is inadequate (see table 13 in appendix for details). On the other hands, Thailand, India, and Indonesia have the top utilization ratio of GSP free tariff lines, respectively. (See table 10 for details)

Further this data highlights that Pakistan's carpet sector at chapter 57 and articles of apparel and clothing at 61 are utilizing hundred per cent of free tariff lines (See table 19 in appendix for detail). However, in term of export value under US GSP free tariff line the most outstanding sectors of Pakistan are chapter 39 (plastics and articles thereof) and chapter 71 (Natural or cultured pearls) with highest exports figures in the calender year 2019 (See table 20 in appendix for details).

7.1 Recommendation

The study recommends the following initiative for short, medium and long term, on the competitiveness of the sector

- In the short run, sectors in category B which have an established supply base in Pakistan and negligible exports to the US may be targeted in order to increase exports to US under GSP free tariff lines on priority basis.
- ➤ In the medium, run those sectors which have significant exports to the US but negligible free tariff utilization ratio may be focused, so that there export under free tariff line can be improved and it also recommended to target those sectors with good utilization ratio but low export in term of value.
- ➤ Similarly in the long run, those sectors with the most free tariff lines and weak supply base shall be the major focus of the policy advisor, trade bodies and relevant associations, so that the supply base may be supported and developed in order to start exporting to US under

these tariff lines that provides a competitive market access to the world biggest consumer market.

8. Appendix

8.1 How do I determine if a particular item is GSP-eligible?

"Articles eligible for GSP treatment are identified in the current edition of the Harmonized Tariff Schedule of the United States (HTSUS), which is published by the U.S. International Trade Commission (USITC). The complete HTSUS can be downloaded from the USITC web site http://www.usitc.gov/tata/hts/index.htm. There is also a searchable version of the HTSUS available at the USITC website. In addition, the USITC maintains the "Interactive Tariff and Trade DataWeb," a searchable database of import statistics and other information, including product eligibility information for GSP and other U.S. preference programs," which can be found at: http://dataweb.usitc.gov.

8.2 Certain articles are prohibited by law from receiving GSP treatment

The list includes most of the textiles and apparel articles, footwear, watches, leather apparel and work gloves and. In addition to that, the GSP statute prohibits eligibility for steel, glass, and electronic articles, which are import-sensitive.

8.3 Criteria for country eligibility under GSP

Bases for Ineligibility of the GSP statute sets forth the ineligibility criteria. These criteria are summarized below for informational purposes only.

- 1) A GSP beneficiary **may not be a Communist country**, unless such country receives Normal Trade Relations (NTR) treatment, is a World Trade Organization (WTO) member and a member of the International Monetary Fund (IMF), and is not dominated or controlled by international communism;
- 2) A GSP beneficiary may not be a party to an arrangement of countries nor participate in actions the effect of which are (a) to **withhold supplies of vital commodity resources** from international trade or to raise the price of such commodities to an unreasonable level and (b) to cause **serious disruption of the world economy**;

- 3) A GSP beneficiary may not afford preferential treatment to products of a developed country that has, or is likely to have, a significant **adverse effect on U. S. commerce**.
- 4) A GSP beneficiary may not have **nationalized**, **expropriated or otherwise seized property of** U.S. citizens or corporations without providing, or taking steps to provide, prompt, adequate, and effective compensation, or submitting such issues to a mutually agreed forum for arbitration.
- 5) A GSP beneficiary may not have failed to recognize or enforce arbitral awards in favor of U.S. citizens or corporations.
- 6) A GSP beneficiary may not aid or abet, by granting sanctuary from prosecution, any individual or group that has committed an act of international terrorism.
- 7) A GSP beneficiary must have taken or is taking steps to afford internationally recognized worker rights, including a) the right of association, b) the right to organize and bargain collectively, c) a prohibition on the use of any form of forced or compulsory labor, d) a minimum age for the employment of children, and a prohibition on the worst forms of child labor, and e) acceptable conditions of work with respect to minimum wages, hours of work and occupational safety and health.
- 8) A GSP beneficiary must implement any commitments it makes to eliminate the worst forms of child labor.

8.4 Handicraft Textiles

Certain textile products are eligible for GSP treatment when the GSP BDC has signed an agreement with the United States to provide certification that the items are **hand-loomed and folkloric** wall hangings **products** of the exporting BDC.

What is the certified handicraft textile agreement?

The certification process requires an official exchange of letters between the U.S. Government and the BDC government. The image of the **triangular seal certifying** the products' authenticity must be **stamped on the commercial invoice** and signed by one of the **individuals identified by the BDC** during the exchange of letters comprising the agreement.

8.5 How is an article identified as GSP-eligible in the HTSUS?

The letter A in the "Special" tariff column of the HTSUS identifies GSP-eligible articles at an eight-digit level. The following table presents three HTSUS tariff lines to illustrate variations in the treatment given to different GSP articles. Under each entry for a GSP-eligible article in the HTSUS, the SPI code A, A+, or A* in the "Special" column identifies the article as GSP-eligible under certain conditions. The SPI code A designates articles that are GSP-eligible from any BDC. The Special Program Indicator (SPI) code A+ indicates articles that are GSP-eligible only from LDBDCs. The SPI code A* indicates that one or more specific BDCs, listed in General Note 4(d) to the HTSUS, have lost GSP eligibility for that article.
