- I. Applications after due date or without valid Pay Order / Bank Draft will not be entertained.
- II. <u>Non-submission of required documents noted against S. Nos 15 (i viii) above shall render the applicant ineligible</u>
- III. The form should be properly filled in and verified
- IV. Wrong and incomplete information may lead to disqualification
- V. Visa recommendation letters will be issued only to Director/CEOs of the companies.
- VI. Once an applicant's selection is confirmed, the participation fee shall not be refunded.
