PROMOTION OF THE "VISA PRIOR TO ARRIV FOR TOURISM AND INVESTMENT

I am directed to refer to the subject cited above and state that the Ministry of Interior has recently introduced a "Visa Prior to Arrival (VPA)" scheme aimed at facilitating tourism and investment in the country. This initiative includes granting visa-free entry to citizens of Gulf Cooperation Council (GCC) countries and offering a 90-day multiple-entry visa to citizens of 120 other countries under the VPA scheme (copy enclosed). The visa will be issued within 24 hours of application, ensuring swift and efficient processing. This scheme is designed to promote ease of access to Pakistan, fostering both tourism and foreign investment.

- Given the strategic importance of this initiative, the Ministry of Commerce is requested that it may effectively promote the VPA by:
 - a. Issuing communications to national and regional Chambers of Commerce, encouraging them to share information about the VPA system with their members, especially businesses with international clients and partners.
