**THE UNITED NATIONS (SECURITY COUNCIL) ACT, 1948.**

**ACT<sup>1</sup> NO. XOVI OF 1948**

**[11<sup>th</sup> June, 1948]**

**An Act to enable effect to be given to certain provisions of the Charter of the United Nations.**

WHEREAS; It is expedient to enable effect to be given to certain provisions of the Charter of the United Nations; It is hereby enacted as follows:

1. **Short title.** This Act may be called the United Nations (Security Council) Act, 1948.

2. **Measures under Art. 41 of the Charter of the United Nations.** If, under Article of the Charter of the United Nations signed at San Francisco on the 26<sup>th</sup> day of June 1945, the Security Council of the United Nations calls upon the <sup>2</sup> [Federal Government] to apply any measures, not involving the use of armed force, to give effect to any decision of that Council, the [Federal Government] may, by order published in the official Gazette, make such provisions (including provisions having extra-territorial operation) as appear to it necessary or expedient for enabling those measures to be effectively applied.<sup>3</sup>

**Insertion of new sections, Act XIV of 1948<sup>4</sup>.**—In the said Act, after section 2, amended as aforesaid, the following new sections shall be added, namely: —

3. **Indemnity.**— No suit, prosecution or other legal proceedings shall lie against any person in respect of anything which is in good faith done or intended to be done under this Act.

4. **Power to make rules.**— The Federal Government may, by notification in the official Gazette, make rules for carrying out the purposes of this Act.

5. **Delegation.** — The Federal Government may, by order, delegate to a Pakistani person, entity or authority, subject to such conditions as may be specified therein, all or any of the powers exercisable by it under this Act.”
