Pakistan - South Africa Trade Relations





Pakistan - South Africa relations have been cordial and amiable since the removal of trade embargos and sanction by EU & US in 1994. During 2020, Pakistan's exports goods worth \$ 183 Mn and imported goods worth \$ 921 Mn recording a huge trade deficit of \$721 Mn. The bilateral trade has remained significantly tilted in favor of South Africa over the years. However, the trade deficit started to decline from \$1.06 bn in 2018 to \$728 Mn in 2020 on account of import contraction, whereas export proceeds continued to be stagnant.

There is no trade agreement in place with South Africa. However, in 2013, 8 MoUs were signed in Joint Commission meeting to increase trade volume. Pakistan also envisaged 'Look Africa Plan' in Sep'17 to increase bilateral trade with African countries. South Africa is included among top 10 African countries.


