<u>An update on Sanitary and Phyto-Sanitary (SPS) issues for export of Pakistan's</u> <u>agricultural products to China</u>

Protocols have been Achieved					
Export of Citrus and Mango	 A team of Auditors from AQSIQ visited Pakistan in May-June, 2016. The experts visited 9 citrus Cold Treatment Plants (CTP) and 18 mango Hot Water Treatment (HWT) Plants. After necessary inspection, 5 citrus CTP and 3 mango HWT facilities qualified Chinese requirements were approved and remaining companies suggested modification by the experts. The report was forwarded to DPP on 6th August, 2016 for necessary corrective measures. According to the expert's advice DDP sent its feedback after necessary modification on 3rd December 2016. The said material was evaluated by AQSIQ and after the necessary evaluation accorded the approval of 9 citrus Cold Treatment Plants and 18 Mango HWT plant in August 2017. Rice	In the first phase, the AQSIQ considered registration of 33 rice exporting companies. Now the next lot of Phase- 2 will be considered in due course of time. This office has contacted AQSIQ to initiate the process of 2nd phase and AQSIQ agreed to register more 10 to 15 companies, DPP replied 10 companies list, list has been transferred to China Customs and approved 4 more companies after evaluation by 29th May, 2020.
