3. Single Stage – Two Envelope Bidding Procedure will be followed for open competitive bidding. Interested bidders shall submit their sealed proposals/ bids comprising single package containing two separate sealed envelopes i.e. Technical and Financial Proposal which will be clearly mentioned in bold and legible letters on respective envelopes to avoid any confusion. The **original sealed Technical Proposal** shall be accompanied by a bid security amounting to Rs. 2,400,000/- with a minimum validity of 60 days from the date of opening of bids in the form of Pay order/Demand Draft/ Bankers Cheque issued by a scheduled bank of Pakistan in favour of TDAP, Karachi.

Sealed Bids, prepared in accordance with the instructions in the bidding documents, must be uploaded on EPADS and must reach the office of the Assistant Director (Tenders/OIC-WEXNET), Trade Development Authority of Pakistan (TDAP), 62 Garden Block, Garden Town, Lahore, on or before 02:30 p.m. on 6<sup>th</sup> September, 2024 Bids will be opened the same day at 03:00 p.m. All the bids must also be uploaded on EPADS.

5. Trade Development Authority of Pakistan reserves the right to reject any or all bids, alter or modify the scope of work/BoQ's and to annul the bidding process at any time in accordance with Public Procurement Rules without assigning any reason.
