Explanations to the Footnotes

- 1. Applicants could be natural or juristic/ legal persons or group of persons claiming to be an operator, producer, or group of producers interested in the right to use a registered Geographical Indication (GI).
- 2. Applicants must be Pakistani nationals or businesses and entities registered in Pakistan. As an evidence, copies of CNIC and NTN are required to be submitted with the application if the applicant is a natural person(s). Whereas, copies of NTN and registration certificate of the business (from FBR/ Registrar of Firms/ SECP) are required for business entities.
- 3. Brief description of goods (Sindhri Mango) and geographical areas for its production be provided.
- 4. "Sindhri Mango" is the GI for which registration may be sought on FORM_TDAP_GI-USER_02.
- 5. Whether the applicant is "producer" or "operator" of relevant goods (Sindhri Mango) be mentioned. Producer is any natural or legal person producing the goods, while operator is someone involved in the collection, transformation, processing, trading, or distribution of GI goods.
- 6. "Statement of Case" is a brief write-up furnishing evidence, supported by relevant documents, that the applicant is a member of supply chain of the GI product (Sindhri Mango) as a producer or operator. Statement of Case is required to be furnished separately as Annex-1 to the application on applicant's letterhead.
- 7. "Book of Specifications" for the Sindhri Mango GI and draft for the "Undertaking" are attached to the Application Form as Appendixes 1&2, respectively. Duly completed Application Form needs to be submitted to the TDAP (along with the undertaking completed on applicant's letterhead and attached to it as Annex-2).
- 8. "Formal Accent" will be granted by the TDAP to applicants submitting duly completed Application Forms along with requisite supporting documents. Key decision parameters in this regard, inter-alia, would be (i) Pakistan origin of applicants, (ii) their membership of the Sindhri Mango supply chain, and (iii) receipt of completed undertaking signifying conformance to the Book of Specifications.
