

## Invitation for Bids

and business, under the Ministry of Commerce, invites sealed bids from firms registered with Pakistan Engineering Council having valid certificate of category C4, Income Tax and Sales Tax Departments and which are on Active Taxpayers List of the Federal Board of Revenue and qualified in following specialization:

- **CE10** - General Civil Engineering Works, Slope Protection System, Concrete Repairs, Soil Investigation and Stabilization, Landscaping & Horticulture, Reclamation Works, General Buildings and Maintenance, Waterproofing.
- **BC01** - Construction of buildings and industrial plants using prefabricated components and systems. Construction of steel framed buildings and industrial plants. Airports Terminal buildings, Satellite buildings, cargo terminals, air traffic control towers, contact piers, passenger loading bridges.

2. Bidding documents, containing detailed terms and conditions, method of procurement, procedure for submission of bids, bid security, bid validity, opening of bid, evaluation criteria, clarification / rejection of bids, performance guarantee etc. are available for the interested bidders at ePADS. 3. Single Stage - Two Envelope Procedure as per PPRA rule 36(b) would be used for Open Competitive Bidding for each work. Sealed Bid proposal should contain Rs.3,000,000/- bid security of the bid amount in the shape of pay order in favour of “**TDAP, Karachi Expo Center**”.

The bids, prepared in accordance with the instructions in the bidding documents, must be uploaded on ePADS website and also submitted Bid Security at the office of the Assistant Manager (Expo), Trade Development Authority of Pakistan (TDAP), 8<sup>th</sup> Floor, Block-A, FTC Building, Shahrah-e-Faisal, Karachi on or before 11:00 AM on 25<sup>th</sup> December, 2025.
